Note: All citations should be double spaced and have a hanging indent in a Reference List. A "hanging indent" means that each subsequent line after the first line of your citation should be indented by 0.5 inches. In-Text and Parenthetical Citation Examples. Quote with author 's name in text. Smith (2019) states that, " ..." (p. 112). Quote with author 's name in reference. This is quoted as, " ..." (Smith, 2019, pp. 112-4). Paraphrasing with author 's name in text. Smith (2019) stated these facts, too.

Your reference list should be ordered alphabetically by author and then chronologically by year of publication. The APA 6th style requires the references to be indented as illustrated below in the examples. For instances of multiple articles with the same authors and years of publication, please check the APA publication manual or Academic Writer. If you have the DOI for the journal article, you should include it in the reference, otherwise, it is not necessary.

Example: American Psychological Association. (2010). Publication manual of the American Psychological Association (6th ed.). Washington, D.C.: Author. Explanation: This includes a name of a study group, government agency, association, corporation, etc. Put the name of the group author in the author position followed by a period.

If this is the title of a book, periodical, brochure or report, it should be italicized. For example: (*A guide to citation*, 2017). Tips: When citing sources that you find on the Internet you only need to include a retrieval date if the information you viewed is likely to change over time (p. 192). If you reference an article from Wikipedia, for example, you would want to include a retrieval date because such information can be subject to a lot of change.
