Misdemeanor of a High and Aggravated Nature: For an aggravated misdemeanor conviction, you will face less than one year in prison and fines no more than \$5,000. Felony: For a felony conviction in Georgia, you will face more than one year in prison and potential fines greater than \$1,000. A pre-sentence investigation may be ordered by the Court or by your attorney to assist the Judge in sentencing.
